TERMS & CONDITIONS (T & C)
FOR THE MJC HALAAL TRUST'S (MJCHT'S) CERTIFICATE

1.0 The MJC Halaal Trust's Unique Ḥalāl Certificate (and the Use thereof):

- 1.1 Is bound by all the Certification laws and regulations, as practiced in South Africa.
- 1.2 Has specific, identifiable features, which may not be altered or tampered with.
- 1.3 Remains the property of the MJC Halaal Trust (MJCHT).
- 1.4 Is valid for the year of issue, only.
- 1.5 Is non-negotiable, not-lendable, and non-transferable.
- 1.6 May not be forged, photocopied, misused, or altered in any way. Such action will result in immediate withdrawal of the Ḥalāl Certificate, with cost and/or legal action against the offender.
- 1.7 The original MJCHT Ḥalāl Certificate of current year must be displayed in a clearly visible position or place within the Ḥalāl certified premises.
- 1.8 Safekeeping of the Ḥalāl Certificate is the responsibility of the Ḥalāl Certificate Holder (HCH).

2.0 The MJC Halaal Trust's Emblem/Logo

- 2.1 All MJCHT Halaal Trust registered certificate holders (HCH) may display the MJCHT's official emblem or logo on their packaging and advertising material.
- 2.2 The colour of the MJCHT's logo may differ, depending on the wrapping of the product.
- 2.3 The MJCHT does not allow the company or HCH to print any loose stickers having the MJCHT's logo on them or to be printed on their labels, stickers, or advertising material, unless by the approval of the MJCHT.
- 2.4 When approved, the loose Ḥalāl stickers must be accompanied by the registration number, which appears on the certificate, duly issued by the MJCHT.

3.0 The Ḥalāl Certified Premises/Facility

- 3.1 The **Ḥalāl Certificate Holder (HCH)** must notify the MJCHT, with immediate effect, of any changes in the name and address of the factory/premises/facility, or new premises used; product brands, changes in ingredients, flavourings, or additives; or change in the manufacturer's details, or suppliers, and any other relevant information of the company; or change of ownership.
- 3.2 In the event of transfer of ownership [i.e. of the Ḥalāl Certificate Holder (HCH)], the existing Ḥalāl Certificate becomes null and void.
- 3.3 The Ḥalāl Certificate Holder (HCH) must return the **Ḥalāl Certificate** to the MJCHT, immediately after its **EXPIRY DATE**, each year of Ḥalāl certification.
- 3.4 The new owner must make his/her own application for Ḥalāl certification at the MJCHT.



4.0 The Fee Structure

4.1 The **Fee Structure** is calculated entirely on the type of production Plant/Facility (this matter is discussed after the **Application Form** for ḥalāl certification is received and before the Application is finalized).

5.0 General Conditions

5.1 By special request and under special conditions, the MJCHT may issue **Duplicate Halal Certificates**, at an additional cost.

5.2 The MJCHT reserves the unconditional right to withdraw the Ḥalāl Certificate. Such decision shall be taken by the MJCHT's Board of Trust (BOT), without furnishing any reasons, which shall be binding on the Applicant.

5.3 In the event of withdrawal of the Ḥalāl Certificate or the Applicant terminates the services of the MJCHT, the MJCHT's Logo on all printed packaging must be removed and destroyed, within three months from the date of termination of services. Failure to do so, the MJCHT shall deal with it legally.

5.4 **Fraudulent** use of the MJCHT's logo or ḥalāl certificate will be dealt with legally.

5.5 Failure to observe the above-mentioned Criteria shall be deemed a violation of the Agreement and as such the Ḥalāl Certificate will be withdrawn with cost. A public announcement to the media and at mosque platforms will also be made thereof. Legal steps may be taken when deemed necessary to do so.

5.6 In respect of clause (1.5 – The MJCHT Ḥalāl Certificate is non-negotiable, not-lendable, and non-transferable), the HCH may not transfer or lend its Ḥalāl Certificate or Logo with its designated HT Registration Number to another outlet, or store, or premises, or facility, which is of the same or other HCH, and/or any other company or facility.

- ❖ Each HCH may use **only** its own HT Registration Number/Logo per premises, outlet, facility, or product.
- ❖ The Applicant hereby agrees to abide by all of the above-mentioned Criteria, all the written instructions and decisions about ḥalāl compliances, duly stipulated by the MJCHT Management and/or its Board of Trust, from time-to-time.

Special Note

- a) All MJCHT Ḥalāl Certificates will be formatted electronically and forwarded to yourselves via email for your convenience.
- b) You may print the certificates on your colour printer.
- c) For printing purposes, you may use the normal copy paper (80g/m²), or a thicker gauge of copy paper (like letterhead quality-paper).
- d) After the printing you may laminate or frame it, and place in a strategic space at your ḥalāl certified facility, where it is more easily visible and accessible for inspection and the customers to see it.
- e) The certificate contains several security features which enable the first print to be the original.
- f) No copies are allowed for circulation or distribution without our prior approval (**See clauses 1.5 & 5.6**).
- g) This method was devised with built-in security aspects to prevent fraudulent usage.
